(Subject to change without notices)

The goods and services shown below are those we can provide for our customers. You may choose as many of the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.) If legal or other requirements mean you must buy items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

BASIC SERVICES OF FUNERAL DIRECTOR AND STAFF AND OVERHEAD..... \$1,400

Our services include: conducting the arrangements conference; planning the funeral; consulting with family and clergy; shelter of remains; preparing and filing of necessary notices; obtaining necessary authorizations and permits; coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.)

ADMINISTRATIVE CHARGE.....6% Charge on the Assignment Amount

Insurance assignment fee.

EMBALMING..... \$550

(Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.)

IMMEDIATE BURIAL SERVICE.....\$2,045 to \$2,990

Our charge for an immediate burial (without ceremony at Funeral Home and church) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains from local hospital; and local transportation to cemetery.

CREMATIONS

If you want to arrange a **direct cremation**, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we can provide are fiberboard or unfinished wood boxes.

Cremation Fee.....\$900

Our charge for direct cremation includes: basic services of funeral director; a proportionate share of overhead costs; obtaining necessary authorizations; and the actual cremation.

Direct Cremation.....\$1,195-\$1,490

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director staff; a proportionate share of overhead costs; removal of remains; transportation to crematory; necessary authorizations; and cremation if relevant.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are a fiberboard container or an unfinished wood box.

ALTERNATIVE SELECTIONS

Ship Out Services

Forwarding of remains to another funeral home using a combo unit.....\$1,300

Fee includes basic services of funeral director and staff, a proportionate share of overhead costs, embalming, combo unit, removal from local hospital, and transportation to Washington National or Baltimore Washington International airports. This charge does not include viewing, funeral ceremony, or shipping charges.

Forwarding of remains to another funeral home.....\$2,150

Fee includes basic services of funeral director and staff, a proportionate share of overhead costs, embalming, casket (M-Flare), airtray, removal from local hospital and transportation to Washington National or Baltimore Washington International airports. This charges does not include viewing, funeral ceremony, or shipping charges.

Ship In Service

Receiving remains from another funeral home with complete local service.....\$2,100

Fee includes services of funeral director and staff, a proportionate share of overhead costs, transfer of remains from Washington National or Baltimore Washington airports to funeral home, use of funeral home for visitation with funeral ceremony at funeral home or local church, and hearse transportation to local cemetery/crematory.

Local church or graveside service.....\$1,700

Fee includes transportation from Washington National or Baltimore Washington International airports, storage facilities, directing funeral ceremony at local church or graveside, funeral director and staff, a proportionate share of overhead costs, and hearse transportation to local cemetery. Fee does not include use of funeral home or memorial service or visitation.

Immediate Burial/Graveside Service.....\$1,450

Fee includes transportation from Washington National or Baltimore Washington International airports, storage facilities, basic services of the funeral director and staff, a proportionate share of overhead costs, and van transportation to local cemetery (no scheduled service or family in attendance). This fee does not include the casket or viewing.
